


This year SEBS also went through a tough time and we had the grief of some of the members due to COVID-19. We share our condolences to all the family members and friends with a heavy heart.

## **Total Fund**





## **SAHAD Online Sessions**

The SEBS Anti-harassment and Anti-discrimination Committee has been one of the most active groups and has been conducting various events on a regular basis. *Unlearn* being one of the regular events by SAHAD where meaningful discussions around diversity, inclusion and social justice are carried out by the guests from in and outside of the SEBS community. So far 7 sessions of *Unlearn* have successfully been conducted.

On the other hand there is an update about a very important step that has been taken by SAHAD along with Budhanilkantha School. A 9 member committee was formed on April 17, 2021 to support the principal in designing strategies, policies and programs to advance diversity. equity, inclusion and social justice in the school. ## **SEBS Oxygen Concentrator Bank**

The SEBS executive committee came up with an effort to support the Budhanilkantha School and SEBS community by forming an Oxygen Concentrator Bank. The second wave of corona virus was hitting the whole nation and as a preventive measure SEBS formed an oxygen concentrator bank. The bank stocked seven concentrators of two different capacities (5 lit/min oxygen flow with an oxygen concentration level of 90-95 percent) and they are currently being stored at Budhanilkantha School's clinic. SEBS and the SEBS family (Students and Staff of Budhanilkantha School) can at any time borrow them for their personal use.

## Budhanilkantha Municipality Oxygen Concentrator Donation

The COVID-19 pandemic affected the entire nation in the year 2020 and 2021. In such a difficult situation, SEBS came up with a lot of activities and ideas to support not only the members but also the community. SEBS donated an Oxygen Concentrator to the Budhanilkantha municipality through the mayor. It was a collective effort of all the SEBSers from across the globe to support the community as there was shortage of oxygen in every big and small health care centers in the country.
