

#### **SEBS Sandhya 2024 - Introduction**

SEBS launched **SEBS Sandhya** as a cultural fundraising event, which quickly gained traction as a prominent entertainment program, especially during the 1980s and 90s. It became a crucial source of financial support for SEBS and significantly boosted its visibility. The event featured renowned artists of the time, including singer Nabin K. Bhattarai and others.

However, the program's regularity waned in the 2000s and 2010s.

In recent years, SEBS Sandhya has made a triumphant comeback, drawing crowds of 2500 to 3000 attendees. These audiences, comprising students, teachers, alumni, friends, and family, have enjoyed electrifying performances from acclaimed artists such as Nabin K Bhattarai and Atripta, Swoopna Suman and the Asters, Pahelo Batti Muni, Sushant Ra Raga, Kada, Sushant KC, and. their dynamic stage presence continues to captivate and excite audiences, further enhancing the event's atmosphere.

SEBS is dedicated to making this musical festival an annual tradition, offering a platform for SEBSers to showcase their musical talents, foster stronger connections within the SEBS community and raise funds for SEBS.

Choosing Budhanilkantha School as the venue holds profound significance for BNKS alumni. For many, the school is more than just an academic institution; it's a beloved home where they spent their formative years, forging lifelong friendships and memories. Hosting the event on the school's premises allows attendees to immerse themselves in nostalgia, reliving the wonderful days spent there and taking a heartfelt journey down memory lane.

Beyond its emotional significance, Budhanilkantha School is an ideal setting for accommodating all attendees. Its expansive grounds and facilities offer ample space to host the event, ensuring everyone feels welcome and comfortable. #### **Report Summary**

The report includes the summary of the musical event from its incubation to the day it kicked off. Information including the financial statement of the income and expenditure of the event has been included in the report. SEBS Sandhya is a grand event that brings together the diverse Budhanilkantha family- SEBSers, students, teachers, parents and friends/partners of Budhanilkantha School. By organizing another edition of SEBS Sandhya on 25 May, 2024, at Budhanilkantha School, SEBS was creating another history. SEBS Sandhya encompassed an entire afternoon and evening of music, nostalgia, and unity, meticulously curated to revitalize current students, reunite former students, and strengthen connections among parents, teachers, and all members and friends of the Budhanilkantha community. The organizers anticipated an attendance of around 3500-4000 individuals. A considerable number of the performers were not only esteemed members of SEBS, but also renowned both within and beyond Nepal for their exceptional talents as singers, songwriters, and producers.

Considering the factors, the organizers were confident that the organization would benefit greatly from the sponsors! The sponsorship with SEBS Sandhya would not only provide an attractive prospect for publicity and marketing of the companies, but also play a vital role in creating a memorable experience for all attendees of SEBS Sandhya. In return, for their generosity, the sponsors were provided prominent recognition for event promotions, on-site branding opportunities, and complimentary tickets to the event in line with their sponsorship packages.

#### **Report Overview**

#### Activities

#### 25 November 2023: SEBS Sandhya Update

SEBS ExComm decided to organize SEBS Sandhya as one of the greatest mega events as a part of alumni activity. President Santosh Bisht proposed Saroj Tamrakar, as the Event Team Lead for SEBS Sandhya and Nitanta Singh Bista and Aditi Singh as Co-Leads. The venue and time for the event were under observation. The team estimated either April or March 2024 for the event, but a clear date would be suggested only after the potential venues were reviewed. ExComm members Aditi Singh and Nitanta Singh Bista were given the responsibility to notify the progress of the event.

#### 26 February 2024: Meeting Update

The seventh ExComm meeting discussed fixing a date for SEBS Sandhya and decided that an appropriate date would be suggested. ExComm nominated a team led by 232C Saroj Tamrakar as the Event Lead, Nitanta Singh Bista and Aditi Singh as the team members as co-leads. The team was given the responsibility to prepare a framework for the event.

#### 9 March 2024: SEBS Sandhya Budget Approval

1<sup>st</sup> June, 2024 was scheduled for SEBS Sandhya to take place in the School premises. Event Management Team Lead by Saroj Tamrakar and Co Leads Nitanta Singh Bista and Aditi Singh were asked to prepare a proposal for fund raising. The team was given responsibility for event promotion, ticketing, stall management and volunteer mobilization and organizing other relevant activities related to the event. They would oversee the entire event management process but closely coordinate with SEBS ExComm as per need. The same meeting decided to give responsibility to SEBSer 375 D Rashik Bhattarai, Garage Entertainment for the management of singers, sound system, stage preparation and other technical arrangements related to the event. Rashik Bhattarai was to coordinate closely with the event management team.

ExComm approved the budget of 17 lakhs for SEBS Sandhya as per the quotation submitted by Garage Entertainment. An extra fifty thousand was allocated for Sabin Rai. A three-member fund raising committee was endorsed lead by Sanjeev Shah, co-lead by Abhishek and Nitanta and members comprising Apsana Shrestha, Aditi Singh, Umang Sharma, Kritika Khadka, and

Shamir Chhetri. Later, Sanjeev Shah, who already had a plan to leave for the USA, had to leave and therefore Santosh Bisht the president took the lead.

#### 21 March 2024: SEBS Sandhya Update

The Fundraising Committee updated the progress of the fund-raised. The team had raised 4.5 lakhs in total: 1.5 lakhs from Cedar Gate and 3 lakhs from NIMB.

#### 15 April 2024: Date Change

The committee realized 1<sup>st</sup> June was not an appropriate date for the event as it coincided with the date of the royal massacre, which was a black day in Nepalese history. Since the incident led to the loss of the founder of the school, the then King Birendra, and two former students of BNKS, King Birendra's sons - 832 A Dipendra and 736 B Nirajan; in light of this sorrowful event and as a mark of respect and sensitivity to the grieving families, it was agreed that 1<sup>st</sup> June would not be an appropriate date for a festive event such as SEBS Sandhya. The school also suggested the date was inappropriate, which was echoed by several other SEBSers.

Several dates were discussed at length. 25<sup>th</sup> May Saturday was a preferred option, but due to unavailability of the artist Sabin Rai to whom an advance of one lakh rupees had already been paid, there was a need to consider holding the event on Friday, 31<sup>st</sup> May, as Rai was not available on 25<sup>th</sup> May. The Republic Day was another option, which was a public holiday, but the artists were unavailable that day too, and there wasn't much time for preparation. The potential loss of one lakh rupees advance to Sabin Rai due to change of date (esp. to 25<sup>th</sup> May) was given serious consideration. Even though most ExComm members were leaning towards Friday, 31st May, as the new preferred date, a few members noted that one day prior to the day of the massacre would also be considered inauspicious per Nepali (Hindu) traditions. Moreover, upon consultation with a couple of the large sponsors, they indicated that a holiday (Saturday) would be their preferred option. As this event wouldn't be possible without sponsors, it was eventually agreed that their preferences should also be given serious weightage, as a result of which the final date was fixed for 25<sup>th</sup> May. ExComm members appealed to Garage Entertainment, the event and artists managers, to attempt to retrieve the one lakh rupees advance given the extraordinary conditions forcing this change in dates, but Garage noted that such a request would be very unprofessional and uncommon in the music scene. However, Rashik mentioned that he would request Sabin Rai to adjust the advance for the next SEBS Sandhya. Most ExComm were not in favor of postponing the event beyond 1<sup>st</sup> June, given the onset of monsoon, and this event being an open-air one. Finally, with due regard to the time pressure too, 25<sup>th</sup> May Saturday, was

agreed as the preferred date, despite the slight financial loss to SEBS, and the added pressure of re-raising this one lakh from other sponsors.

#### 16 May 2024: SEBS Sandhya Date Announcement

The Executive Committee of Society for Ex-students of Budhanilkantha School (SEBS) announced the eagerly awaited event SEBS Sandhya, a musical extravaganza set to captivate the audiences to be held on 25<sup>th</sup> May, 2024. SEBS Sandhya would be held at the Middle Pitch of Budhanilkantha School, commencing at 11:00 am and continuing till about 7:00 pm. Attendees would get to listen to musical performances spanning various genres from our own artists and collect life time memories. The event would serve as a platform for our talented alumni to showcase their musical prowess while fostering a sense of community among current students and fellow ex-students.

Tickets were made available online through Khalti. Early booking was recommended to secure places for early birds.

## 25 May 2024: The Day

The opening of the event started with a welcome speech by Keshar Khulal, principal of Budhanilkantha School. He welcomed all the participants and expressed his great pleasure to welcome everyone in the school premise. He mentioned that he was thrilled to support SEBS Sandhya in the school, as the event beautifully embodies the unity between the alumni and the current students. He further highlighted that music played a pivotal role in education by offering innovative and creative ways for students to learn and express themselves. He went on to say SEBS Sandhya is a testament to the enduring bond and commitment the alumni have towards enriching the school's culture and community. He said he was deeply thankful to SEBS for organizing this wonderful event and for their continuous support. He wanted everyone to enjoy the event filled with melodious performances and celebrate our shared love for music and education.

Opening act of SEBS Sandhya 2024 was performed by the current students of 6000E 'Bob & Brothers'. A six member band team, each bringing unique talents and a distinct voice. Sarthak's powerful vocals and raw emotions stood out, while Rijan and Utkrista added complexity with their intricate riffs and soulful solos. Bassist Sushant drove the music forward with a relentless pulse, and Hridayendra's infectious rhythms got the crowd's feet moving. Special addition Aaron enhanced their sound with his flute mastery. What a performance!

SEBS Sandhya 2024 opening act was performed by the current students 7041E Aalok, 7042E Pratyush, 7059E Shardul, 7086E Yugeen and 7127E Kashyap. They came together with 'When Jhol Met Momo' to start the show.

4165E Oscar Kafle made his debut during SEBS Sandhya 2022 as a student of the school. This time he returned to the stage as a SEBSer and rapped his way blowing our minds with a memorable performance.

SEBS Sandhya at Budhanilkantha School began with a spectacular evening of music and artistry, featuring a stellar lineup of Nepal's beloved artists. The event began with the soulful melodies of Pahelo Batti Muni. The band delivered a mesmerizing set characterized by their unique fusion of contemporary sounds, creating a deep connection with the listeners. Sushant Ra Raga added to the evening's diverse musical palette with their innovative arrangements and passionate delivery. The band Kada brought an intense and raw energy to the stage, their performance marked by powerful rhythms and compelling vocals. The band was really 'Kada' as the name suggested. Swoopna Suman and The Asters followed with an electrifying performance that seamlessly blended modern pop with traditional influences, captivating the audience with their dynamic stage presence and engaging energy. Sushant KC's performance was the perfect finale, as he enthralled the audience with his most loved lyric and charismatic presence, leaving a lasting impression. Throughout the evening, each artist brought their distinct style and flair to the stage, making SEBS Sandhya a memorable celebration of music and culture. Last but not the least, it was Nabin K Bhattarai and Atripta, whose harmonies set a serene and emotive tone for the night.

SEBS Sandhya was a vibrant musical event where the entire ground was adorned with stalls, offering sponsors a chance to showcase their products. SEBSers and current students had the opportunity to set up food stalls, presenting a delightful array of local and international cuisines. The school's volunteers played a fantastic role in managing the stall setup, ensuring everything ran smoothly. The stage and stall management infused life into the entire event, creating a lively atmosphere. School children were seen thoroughly enjoying the various food options available at the stalls. Guests and students danced to the music, which was mentally refreshing for everyone, especially the students. The event fostered a sense of community, bonding families together. The combination of delicious food, engaging music, and well-organized stalls made SEBS Sandhya an unforgettable experience for all attendees.

Santosh Bisht, president of SEBS gave a speech to thank all the artists, organizers, event management team, school team and the audience. He expressed his sincere gratitude to the entire school staff, particularly the committed teachers, and Mr. Keshar Khulal, the principal, for kindly allowing us to use this fantastic premise. He thanked the catering staff for providing delicious food and the Sports department for letting us use their office.

He gave a brief history of SEBS Sandhya and mentioned that with the admirable goal of fundraising, the first and second batches of SEBS pioneered SEBS Sandhya's rich history, which has been carried on by numerous subsequent generations. Due to unavoidable circumstances there was a pause. He further emphasized that during Hemendra's tenure, this tradition was brought back after a 20-year break, and his team did an amazing job. He highlighted that it is an honor for us to hold this torch forward, and he hoped that the legacy will be carried on by upcoming generations. The prime objective of conducting SEBS Sandhya at Budhanilkantha School is to bring our entire family together—students, parents, teachers, friends of BNKS, and the broader community. Our goal is to forge on as a unified team, fostering fraternity and camaraderie. This event demonstrates our unwavering support for the school. He further mentioned that organizing SEBS Sandhya has been a challenging task, but it has come together beautifully due to many well-wishers. He expressed his deepest gratitude to each individual and especially to our generous sponsors.

#### 8 June 2024: SEBS Sandhya expenditure update

The expenditure of SEBS Sandhya was approved by the ExComm on June 8. The income and expenditure of the event is attached at the annex of the report.

#### **Lessons Learnt:**

The musical event SEBS Sandhya at Budhanilkantha School offered several key lessons about music and SEBS community engagement at the preparation.

- 1. Early and Detailed Planning is Crucial: Successful events require thorough planning well in advance. This includes securing the venue, booking artists, arranging for equipment, and coordinating with vendors. Detailed schedules and contingency plans help manage unexpected issues. Do not decide things in a hurry. Take your time. The saying suggests that when we hurry, we are more likely to overlook important details, make errors, and ultimately waste time, resources, or opportunities. In essence, the proverb advocates for patience and deliberate action as keys to success. In case the date hadn't been changed, we wouldn't have lost one lakh rupees.
- 2. Coordination, Collaboration and Ownership: The event demonstrated the critical role of organization, collaboration and buy-in from the members in executing a successful large-scale event. Not all SEBS ExComm were able to be present to organize the event. This is one of the biggest events in the BNKS alumni history and everyone was not present to celebrate the success! However this could also be due to lack of understanding of the depth of the work required, therefore it is important that everyone is onboard from the onset in order to be part of the process. It is also important that the delineation of responsibilities amongst the ExComm, Event Management team and the Music, Artists and Stage management team is clearly stipulated in a written TOR. Ideally, it should be clear that the SEBS ExComm are the owners, and ultimate decision-makers, of this event. It's up to the ExComm to then delegate away responsibilities to the other stakeholders. At times during the lead-up to the 2024 SEBS Sandhya, it felt as though the Event Management Team exceeded their authority, knowingly or unknowingly causing tension among the different stakeholders. Similarly, it appeared some ExComm members may also have overstepped their authority/boundaries in the past in dealing with other stakeholders. Fortunately, Budhanilkantha School's values and the bonding fostered between its students/alumni, ensured such tensions were well managed. However, rather than relying on ad-hoc resolutions, it is better to have all roles and responsibilities clarified beforehand in a written TOR, that puts the SEBS ExComm as the ultimate authority, and other stakeholders as answerable to it, in organizing this event.
- 3. **Camaraderie and Solidarity Feeling:** The event served as a reminder of the profound impact that music can have on individuals and communities, creating lasting memories and strengthening social bonds through shared experiences. Will SEBS be able to host such a mega event every year? A big lesson to be learnt. To organize such events leadership acumen and team spirit will be a prerequisite, organizing SEBS Sandhya cannot be taken lightly.

- 4. **Budget Management is Key:** Proper budgeting and financial management are crucial to avoid overspending. Organizers must account for all potential expenses and set aside a contingency fund for unexpected costs. Advance payment from sponsors cannot be ensured and therefore it is important to have at least one million rupees balance in the account prior to the event.
- 5. Adaptability and Problem-Solving are Vital: Despite thorough planning, unexpected issues will arise. Being adaptable, staying calm under pressure, and having strong problem-solving skills are essential for addressing challenges quickly and efficiently. Satisfying everybody is difficult and therefore being calm and addressing challenges are key to success.
- 6. Attracting more SEBSers to the event: Despite reaching out to the batch representatives and individuals through messenger and emails it seems the communication fell short to attract a large number of SEBSers to the event. Given the event itself is named "SEBS", and one of the objectives is to provide an opportunity for the alumni to not only get-together with each other, but also to visit back the alma mater, participation by SEBSers felt a little short in both the revived SEBS Sandhyas in 2022 and 2024. Therefore new ways of communication, outreach, and marketing need to be explored to attract more audiences, particularly SEBSers, for participation and funding (through ticket purchases).
- 7. **Marketing and Promotion Drive Attendance:** A well-planned outreach strategy like extensive digital ads and boosting could have significantly reduced costs by minimizing marketing. Digital marketing could have not only been cost-effective but also foster a stronger sense of community involvement and support.
- 8. **Safety and Security Cannot be Overlooked:** Ensuring the safety and security of attendees, artists, and staff is paramount. This involves crowd control measures, emergency plans, sufficient medical support, and compliance with local regulations.


